

What is E-Vendor

E-Vendor is an user friendly, intuitive and self serve supplier portal that helps Suppliers and Buyers communicate with each other; it covers the end to end supplier lifecycle relationship from Supplier Onboarding, Purchase Order to Invoice collaboration and reporting for both EDGE Buyers and our Suppliers

Benefits of adopting the E-Vendor Portal for the Supplier & Procurement Function

E-Vendor helps suppliers stay up to date with EDGE's requirements, purchase orders, and receivables leading to better planning and reduced need for voice and email communications. Similarly, it helps our Procurement team to be aware of order confirmation, dispatch plans, shipment details and delivery dates.


How E-Vendor will impact our Suppliers

CHAT BOX QUESTIONS



- What is the reason to "reject" a supplier registration rather than "resubmit"?
 - Reject is a rare scenario which can be used as last option to scrap the request for some reason in which it not ideal to proceed with approval.
- Will the presentation be shared with suppliers for future reference?
 - Yes, all meeting attendees will be sent a copy of the step by step training materials before March 1st 2022
- Will the supplier receive email notifications when the approvals/rejections/requests for resubmission are executed on the portal?
 - Yes, suppliers will receive email notification for each action notification via email will received by supplier and buyer
- When do you plan to start sending out invitation emails to suppliers and when is the system "go live" date?
 - The system Go Live Date is the 1st of March 2022, Invitations to register in the E-Vendor Portal can also be expected on the 1st March 2022
- If a supplier changes its registered company name in the future, can this be updated easily online?
 - Yes, it can be updated, by contacting edge support team at **<u>E-Vendor@EDGEgroup.ae</u>**. Suppliers do not need to re-initiate the registration process from scratch.
- If the PO is approved by the supplier and Edge, will the data will automatically go to ASN? Will Invoicing also be done in E-Vendor portal?
 - Yes, if a change of schedule item (change PO item) is approved, the item will be confirmed in the E-Vendor system
- Will the submission of required work permits be handled on the E-Vendor portal?
 - No, Please continue to submit work permits as before by email
- Will the supplier be able to check email notifications on the portal itself.
 - No, email notifications are sent to your registered email address and will not be displayed on the E-Vendor portal.
